It is the responsibility of the Supervisory Committee to ensure the Credit Union is meeting Members' financial needs and is financially safe and sound.

The Supervisory Committee meets regularly to examine reports to confirm Members' assets are safe and secure.

A key component of the Credit Union's internal control is the Internal Audit Department. The Internal Auditors meet with the Supervisory Committee bi-monthly to review internal and external audit reports, risk assessments, and internal control practices.

Independent auditors, examiners from the State of Tennessee Department of Financial Institutions, and the National Credit Union Administration (NCUA) annually scrutinize Credit Union statements and records.

The Supervisory Committee is pleased to inform you that the financial condition of the Knoxville TVA Employees Credit Union concerning the above-mentioned is correct and precisely represented.

## **Mitchell Weaver, Assistant Treasurer**

I am pleased to report our Credit Union continues to grow as the result of our mission of "Helping Members Grow Financially." 2023 was another great year of excellent financial performance.

## 2023 Highlights:

- **◄** Assets reached almost \$4.3 billion, a 14.26% increase.
- **◄** Deposits grew by 12.93%, an increase of \$419.8 million.
- **▼** Loans outstanding reached \$3.6 billion, an increase of \$222.2 million.
- ▶ With all this growth, the Credit Union remains well-capitalized at 9.30%.
