# **Frequently Asked Questions**

#### **Q** Do I need to pre-register?

A In order to be eligible for door prizes, Members will need to register for this event on our website. You do not need to register to watch the live event.

#### **Q** How do I register?

 A We're glad you asked! You can register online at tvacreditunion.com/annualmeeting starting February 9, 2021. You will need your account or Member number and a phone number to complete the online registration form.

#### **Q** How will I be able to join the Virtual Meeting?

A We'll be setting up a Facebook Live Event for Annual Meeting. Facebook will send you an automatic reminder if you RSVP to the event. To join live, just visit our Facebook page @tvacreditunion. It's easy!

#### **Q** Do I need to have a Facebook account to participate in Annual Meeting?

A Yes, you will need a Facebook account since we are broadcasting the event through Facebook Live.

#### **Q** Will there be door prizes?

A All Members who register for the event are entered into a random drawing for door prizes. We'll also have prizes available for kids (those seventeen and under do not need to register in order to be eligible). We'll announce the winners at the end of the Meeting!

#### **Q** Do I need to be present during the Facebook Live to win?

A No, you do not have to be present in order to win. However, you must be a Member and pre-register prior to the event to be eligible for the door prize drawings.

- Will be available by October 1, 2020, at all branch locations for persons interested in running for one of the three open Board positions.
- Must be completed and include a petition of at least 500 signatures of Knoxville TVA Employees Credit Union Members age 18 or older.
- Must be postmarked by December 4, 2020, and mailed to: Knoxville TVA Employees Credit Union, ATTN: Secretary for the Board, P.O. Box 36027, Knoxville, TN 37930.
- There will be no nominations from the floor, nor an election conducted by ballot at the Annual Meeting. If more nominations than vacancies for the Board of Directors are received, Members will be notified at least 30 days prior to Annual Meeting.
