- ❑ Applications must be postmarked by December 5, 2022, and mailed to Knoxville TVA Employees Credit Union, ATTN: **Secretary for the Board, P.O. Box 36027, Knoxville, TN 37930.**

There will be no nominations from the floor nor an election conducted by ballot at the Annual Meeting. If more nominations than vacancies for the Board of Directors are received, Members will be notified at least 30 days prior to Annual Meeting.
